## **MADDENING MARCH**

March is one of those months where you can either get a beautiful day in the 50s or a downright nasty day with snow or a torrential downpour. Fortunately for 85 Travelers and their guests, the former ruled the day on March 20<sup>th</sup> for "The Original March Madness" at Orvis Sandanona.

Sandanona is a course where the environment is an integral part of the experience and the Orvis staff took all the necessary steps to make it a perfect day. We shot fifteen stations over the rolling hills of Millbrook, New York.

I really enjoy shooting targets where the target setter doesn't try to beat you with speed and distance, but relies on changes in terrain and target movement to fool you. Station five was one of those signature Orvis stations with a hanging battaue followed by a fast driven bird on report. The slow movement to the battaue messed up any rhythm you might have been in to get in front of the driven bird.

Station eight, or “Streamside Snipe”, really took advantage of the terrain. The shooting station was positioned just off the edge of a stream that ran between two hills. The trapper launched a true pair of trap-like targets from the right of the shooter and they flew upstream. The birds looked like they were from the same machine, but by the time you picked which one you wanted to shoot first they were a good 3 feet apart with the bottom bird starting its descent before the top bird.

“Fur and Feather”, otherwise known as station fifteen, was a quartering rabbit on the ground followed by a true crossing bird on report. The perfect spot to hit the bunny was right where the target ducked behind a woodpile. You either had to take the target at its full speed before the woodpile, or after the obstacle and risk misjudging the distance. After watching the squad in front of us decide to take the bunny first, Bob Holtzman suggested that if you took the bunny after the woodpile you would be setup to catch the crossing bird quicker. Sure enough, we seemed to do pretty well using that method.

### **Travelers Tidbit**

**Did you know that awards will be presented based on Lewis Class for the next two shoots? We are trying Lewis Class scoring to expedite the awards ceremony after lunch.**

Sure, there were some high scores. The median score was 78, but nobody broke them all. In fact, Bill Bretschger walked away with the HOA with his 89 and some other heavy-hitters in attendance were also in the high 80s. From the very top to the very bottom, we all had a good time. In my opinion, there’s no reason for the HOA to go home with a 72 at a local event. Pardon me while I put away my soapbox.

A very hearty lunch followed at Copperfield’s. Paul Elsenboss gave us an update on little Amanda Elsenboss who is now the soldier of the year at the US Army Marksmanship Unit! Amanda is a shining example of the young people that came through our ranks in the Junior’s program. Awards followed on the trial run of Lewis Class and somehow Fred Roesslein ended up winning a couple boxes of shells. Fred always seems to go home a winner, but mostly on the days Carol decides to shoot.

Mark your calendars for April 17<sup>th</sup> and May 15<sup>th</sup>. The Travelers visit two very exclusive clubs back to back. First we head over to Ten Mile River Preserve where Buck will pull out all the stops and throw some fun targets for us. In May we travel up the road to Mashomack Preserve where our 2008 Sporting Sportsman of the Year, Charlie Conger, will have a fun day in store for us. We love all the places we shoot, but these are two courses you need an “invite” to shoot at any other day.

The Youth Committee formed at the Travelers Annual Meeting had their first official gathering at March Madness on March 20<sup>th</sup>.




