The pink targets were brilliant against the snow white background. Some shooters were lucky enough to have the targets come out on top of each other and managed to get both with a single shot. You couldn't count on having a pair close together, so you still had to have a plan when they didn't.

The flat light of the overcast day played tricks with us on station five. A quartering bird from the shooter's right was glowing against the snow. Once it got high enough, the target transitioned to the leafless trees and it was hard to see.



Station one was quite challenging for me. The first bird of the pair was launched off a trap about 15 yards away on the shooter's right off a platform. It sailed high in the air in a pretty straight line. The report was an outgoing teal type bird from about 10 yards right in front of the shooter. I don't know if it was because station one was our last station or what, but it was one of the most difficult stations for both myself and Tom Fiumarello.

Some shooters had the unique opportunity to hit a "lucky" green bird. If you hit the green bird, you got a free round at Orvis Sandanona! Ed Davies and Rob Boissonneault saw the lucky birds on our squad and pulverized them both.

We had a great squad with Darcie Shewokis acting as the team manager. Rob Boissoneault was on fire with his best round ever and was smiles from ear-to-ear. We have something very special planned for you on Sunday, April 19th.

There are two significant events in April; paying your taxes and shooting "Double Taxation"! You might say we're giving you sort of a refund with our event in April because we're having two shoots on the same day!

CART DO'S AND DONT'S

Golf carts and ATVs have become an integral part of our sport. We use them to haul our aging bodies and all the associated paraphernalia we "must" have with us to complete our round. Here is a summary of the "Rules of the Road" for motorized vehicles:

- DO park your trailer in a designated trailer parking area.
- DO NOT use the course as your opportunity to "open `er up".
- DO stay on the cart path.
- DO follow the Tonucci Axiom; two person carts are for two people, not four.
- DO NOT go screaming past somebody shooting in the box.
- DO leave room on the cart path for other vehicles to pass.
- DO NOT pull up three feet from the shooting stand.
- DO NOT go into areas if they are roped off.
- DO be courteous of walkers and give them the right of way.
- DO have proof of insurance available for your vehicle at host clubs that request it.

Remember that we are invited guests at a great number of clubs where we shoot. We want to respect their facility so we are invited back another time. Cart courtesy is just another way to show our appreciation to our hosts.

SPRING TRIP 2015

Friday, the first day of Spring, was chilly and damp. A few of us who drove in Thursday evening, including George Parsons, Gwyn and myself, got an early start at Pintail Point. For those who haven't been to Pintail this year, the news is very good. They have new traps at all of the stations, a new wireless card system, and, along the river, a second course with eight new stations shooting into the open fields. There was a good mix of targets—including close in quarterers and crossers, high slicing outgoers, and developing incomers. Something for everyone.

Those of us who got there early had some light snow flurries that turned to damp snow and sleet as the morning went on. It wasn't too bad at first





(and it helps that the first dozen stations are covered) but, as we were finishing up around noon and the majority of the group arrived, the temperature warmed up and everything turned to rain. We, and most others, decided that there was enough shooting left to do that we passed on the afternoon.

That evening the rain stopped and we met at the bar at Harris' Crab House to enjoy a few adult beverages. As usual, the folks at Harris' treated us to a fine meal

Route 84 West, exit 20/Route 684 North to the CT/NY State Lines. Take Route 22 North towards Pawling. Continue on 22 North to Dover Plains. At the traffic light turn right onto Mill Street (just past McDonalds) and continue to Berkshire road on the left. Follow Berkshire road to the Lodge. (845) 877-3560. Park in the lot adjacent to the lodge.

DIRECTIONS to Dover Furnace:

Take Route 22 North at Brewster, NY, for approximately 21 miles to Dover Furnace Road. Turn left onto Dover Furnace Road and proceed approximately one mile to club entrance on left at the stone pillars.
