## **SHOTGUNS IN THE BIG APPLE**

As all of our members no doubt realize, New York State has strict gun laws. New York City is even more strict. Recently some members have raised questions about the legality of traversing New York City with shotguns en route to a shoot. This article is intended to prevent jittery hands on the steering wheel on the way to the next shoot that includes a route through a portion of the Big Apple.

The general rule about possession of shotguns in New York City is that "It shall be unlawful for any person to have in his or her possession any rifle or shotgun unless said person is the holder of a certificate of registration for such rifle or shotgun".<sup>1</sup> The certificate of registration is issued by the Police Commissioner of New York City and is required to be produced upon demand by any police officer. Failure to produce the certificate is presumptive evidence that the person is not authorized to possess a shotgun in NYC.<sup>2</sup> It is also presumed that all persons in a vehicle are in possession of any shotgun in the vehicle lacking a certificate of registration. It makes you want to carpool on the way to shoots, doesn't it?<sup>3</sup>

The penalties can be significant for possessing an unregistered shotgun in New York City. The first offense is only a violation punishable by a fine of no more than a \$300, nor more than 15 days in jail, or both. However, a second offense constitutes a misdemeanor punishable by a fine of no more than \$1,000, nor more than 1 year in jail or both.<sup>4</sup>

At first glance the above rules may make you start plotting routes around New York City to get to M&M. Maybe you are checking the ferry schedules to bypass NYC to get to shoots on Long Island. Don't bother, just pay attention to the exemptions in the Administrative Code. Section 10-305(i)(1) is our free pass through NYC. Just be sure to take all steps to qualify for the emption, which are:

1. You are a non-resident of NYC,
2. You are in transit with the gun to a location outside of NYC,

3. You are in NYC less than 24 hours,
4. The entire time you are in NYC, the shotgun must be:
  - (a) unloaded, and
  - (b) in a locked case or in a locked automobile trunk; and
5. It is lawful for you to possess that shotgun in the place of your residence.

OK, so relax and take the short route to the shoot, but make sure the gun is locked away. Leaving the gun in a soft sided case on the back seat or in the back of an SUV is a good way to get yourself arrested. Oh, and remember to be out of town within 24 hours. No extended stop-over to visit the old girlfriend, please.

## **FALL TRIP 2015**

Friday, we are spending the day at The Shooting Academy at Nemecolin Woodlands Resort <http://www.nemacolin.com/activities/sporting-clays-pa> Featuring 35 sporting clay stations spread across three courses, towers and a five-stand pavilion with an integrated Wobble Trap Field, the course can challenge everyone. Friday we shoot one of the courses in the morning, have lunch in the Clubhouse and then shoot another course in the afternoon.

Saturday we spend the day at our base of operations, Seven Springs Mountain Resort <http://www.7springs.com/sporting-clays-at-seven-springs/>. Rated one of the best facilities in the country, there are two challenging courses and a super sporting course that take advantage of the natural beauty of the surrounding Laurel Highlands. Again, we will shoot one course in the morning and the other course in the afternoon.

Sunday morning, we start for home with a stop at Buffer Creek Sporting Clays where we will enjoy shooting on rolling fields and woodlands.

Home for the weekend will be Seven Springs Mountain Resort. For those non-shooters in the group, Seven Springs offers many alternative activities including the Trillium Spa, a perfect place to relax, unwind and renew. Dinners both Saturday and Sunday will be at Seven Springs. We have a block of rooms reserved under the Ct. Traveler name at a special rate of \$225 per night. We recognize that rate is a bit higher than usual. If you prefer to stay somewhere less expensive, in Donegal PA (about 20 minutes away) there is a Holiday Inn Express (724.593-1881) and a Days Inn (724.593.7536) with less expensive rates.

Columbus Day Weekend is a very busy time at Seven Springs given the opportunity for a longer weekend with excellent leaf peeping. Rooms fill up fast. In addition, this is longer trip than usual with most starting out on Thursday. Hence, we wanted to give you plenty of time to make your plans. I suggest that if you are considering joining us, you should make your room reservations as early as possible.
